- 2. <u>Eligibility.</u> Open only to legal residents of the 48 contiguous United States, 18 or older. Employees, officers and directors of Sponsor, its parent, affiliates, subsidiaries and agencies (including Votigo, Inc.) are not eligible to enter the Contest or win the prize. Offered only in the 48 contiguous United States. Void in Alaska, Hawaii, Puerto Rico and where prohibited by law. - (d) any action will be brought by you individually (NOT as part of a class action);
- (e) your recovery in any such action is limited to actual costs involved in participating in the Contest (if any), with all rights to attorneys' fees and any and all damages (including special, compensatory, punitive, consequential damages) being expressly waived.
