Entrant can also share their photo/video via our Instagram account by tagging @izipusa #betterwithanebike. Entrants must follow all instructions in order to submit a potentially eligible entry. To be eligible to win the prize, completed entries must be

received by Sponsor during the ("Entry Period"– which begins at 12:00 a.m. Pacific Time ("PST") on Friday, February 26th, 2016 and ends at 11:59 p.m. PST on Thursday, August 31th, 2016). All photos/videos must be in great quality. Entrant must submit their photo/video riding, standing with any of our IZIP eBikes or the bike by itself. If submitting an eBike Story, it needs to be around 100-200 words. Entrant can participate with different photos/videos/stories. Just make sure to submit the best ones. Submitting similar photos/videos/stories during the entry period would disqualified the entrant from the contest. Sponsor's computer is the official time-keeping device for this Promotion.

Sponsor is not responsible for computer, communication, or network problems or other submission errors that result in late or damaged entries. Sponsor is not responsible for any potential entrant's failed attempt to upload or download any information in connection with the Promotion, or any technical malfunction that occurs during the entry process.
